## IV. Exhibit Room Report - Liz Kneer

lola Car Show Exhibit had a total of 3428 visitors with many from out of state. Arts Hub Exhibit had a total of 2523 visitors, also many from out of state and one from Rwanda. The Bethany exhibit has had a delay in opening and should be open soon. There will be three adult programs with the Bethany exhibit. The end of year exhibit will be on Women.

The newspaper digitization project is delayed due to the pandemic. YuleTide Trail is scheduled for Dec. 3 and a new Waupaca Area Public Library website is coming that will be easier to navigate.

## VI. Library Report by Eric Bailey, Library Director

- 1. Digitization Update The project has been delayed. The goal is to host a Waupaca History 101 exhibit next year to show off the digitized newspapers. Because of the delay the \$7,020 grant from the WI Humanities Council was in jeopardy with a hard deadline of Oct. 31, 2022. We can submit the cost of uploading the digital files, so we won't have to give back money. The first phase of 90 reels was \$14,000 plus upload costs. Phase II (not funded or started at this time) will be approximately \$20,000 plus upload costs.
- 2. The outdoor pop-up logo sail signs that were funded at our July 2022 meeting were purchased and shown to Foundation members in the library.
- 3. Four community Story Walks are popular. The Foundation continues to sponsor the Library's Story Walks.
- 4. Request for Donation A request of \$500 for Catalog Tablet Replacements.

The first meeting of this ad hoc committee will be Oct. 12 at 9:30AM at the Library.
- B. President Vance Linden also discussed having the Library Foundation meet six times per year instead of four times per year.
